## INTERNATIONAL STUDENT AFFIDAVIT OF SUPPORT REQUIREMENTS

Use this form if you will be requesting an I-20 form to obtain an F-1 student visa. An I-20 cannot be issued until an acceptable Affidavit of Financial Support and bank certification have been received by Oak Hills Christian College.

International students must have enough financial funds to pay the full cost of their educational and living expenses, and their dependents, if any. **2024-25 School Year Costs -- \$36,966\*:**

Tuition & Fees -- \$19,440

Room & Board -- \$ 10,526

Books, Health Ins., Transportation, etc.-- \$7,000

*\*All figures are estimates and subject to change each academic year.*

### **THE FOLLOWING DOCUMENTATION -- ALL TRANSLATED INTO ENGLISH -- IS REQUIRED:**

**NOTE: Documents must be current to time of application and acceptance. If acceptance is delayed for any reason, new documents must be submitted for a later acceptance date.**

- 1. Current Copy of your Passport.**
- 2. Personal Affidavit of Support.** This is required from the person or persons (self, parents, or other) funding all educational and living expenses for the applicant to attend Oak Hills Christian College. A separate affidavit is required for each sponsor. The total funds on the affidavit(s) must equal or exceed the total funds needed for each year of study at Oak Hills Christian College (OHCC). The amount must be stated in U.S. currency and the sponsor must commit to provide full financial support for the applicant's educational and living expenses for the entire length of study at OHCC. If a spouse and or child is included, the Affidavit must include adequate living expense support for them as well.
- 3. Agency Affidavit of Support.** If you are being sponsored by an agency or company, the Affidavit of Agency Sponsorship is required. A separate affidavit is required for each agency sponsor. The total funds on the affidavit(s) must equal or exceed the total funds needed for each year of study at Oak Hills Christian College (OHCC). The amount must be stated in U.S. currency and must state the agency sponsor will provide full financial support for the applicant's educational and living expenses for the entire length of study at OHCC. If a spouse and or child is included, the Affidavit must include adequate living expense support for them as well.
- 4. Bank Statements.** As stated in above, each Affidavit of Support, personal and/or agency, must also attach a current bank statement and a letter bearing the bank's seal and signature stating that funds can be transferred. *Financial documents dated more than six months prior to the date of I-20 issuance cannot be accepted.* New documents will be required if an affidavit and/or bank certification have expired. **Note: Bank statements must be from a checking, savings, or time deposit account. Brokerage, stock or equities funds; real estate and/or any non-liquid assets will not be considered.**
- 5. Scholarship/Loans.** If you have been offered a scholarship, you must provide a copy of that award letter. If you are receiving a loan, the offer must be in English and must specify the amount that is being provided to you for each term. The letter must also show the terms and conditions of the offer.
- 6. Dependents.** For dependents who are accompanying you, please provide a list of their names, their relationship to you, date of birth, city and country of birth, along with a copy of the passport for each dependent. You are also required to **provide proof of \$5,000 in additional funds for your first dependent, and \$3,000 for each additional dependent.**
- 7. Additional Information about financial documents:**
  - FINANCIAL DOCUMENTS WILL NOT BE RETURNED TO YOU. If you are submitting official documentation, please be sure to obtain duplicate original documents for your visa application/interview.
  - Additional documentation may be required at the discretion of the Admissions office.
